## REGULATIONS

### 1. ENTRY REQUIREMENTS

Short films from all countries: fiction, animation, or experimental can be submitted to the selection committee. Commercials are not accepted.

Short films should be in French or with French sub-titles, or without dialogue.

No more than 25 minutes for the general competition et no more than 15 minutes for the children competition.

### 2. ENTRY PROCEDURE

Participants must enter their films via the online submission website  
[www.shortfilmdepot.com](http://www.shortfilmdepot.com)

The following material must be attached to the online submission:

- 1 still from the film (either colour or black and white depending on the film – no poster, no pictures of film set or crew), which can be used in any publication;
- 1 uploaded video file of the film.

The transfer of a video file for preview purposes requires the purchase of a stamp on  
[www.shortfilmdepot.com](http://www.shortfilmdepot.com)

Submission deadline: 25<sup>th</sup> of March 2018

**Participants declare that they hold all of the copyrights, intellectual property rights and all other types of rights, or the authorizations required (images, music, text , ..) for the film to participate in the competition. No screening fee shall be paid.**

### 3. SELECTION

Films are selected by a committee chosen by “Association courts métrages dans le Haut Var”, originality and technical quality are important criteria.

Films submitted during previous years or films where friends or family of jury members are involved, can only be screened outside the competition.

The list of the selected films will be available on [www.festivalcourtscourts.fr](http://www.festivalcourtscourts.fr) on 10th June 2018.

All the selected films contacts will be informed by email.

#### **4. TECHNICAL REQUIREMENTS FOR THE SCREENINGS**

You shall be asked to send a video file (type MKV, AVI, MOV), full HD, 1080 p. It should be possible to read it with VLC.

No DCP, no sound 5.1

#### **5. JURY AND PRIZES**

Every year the association chooses a jury of professionals from the film world, artists, or residents of the region to award prizes.

There are also awards by the audience, by vote.

No money prize will be awarded, but "Malons": the festival trophies.

Children award their own prize : Prix des Pichoun

#### **6. INVITATION**

No expenses will be refunded.

Selected films crew members are very welcome to come and participate in the festival and meet the public. Please contact the association to discuss the possibility of travel arrangements and of accommodation in private homes.
